### ORDER

The Board introduced a special scheme vide order read as 1st paper above to settle pending outstanding arrears of EHT, HT & LT consumers for the period from July 2012 to October 2012 and further extended till 31.12.2012 with conditions. Consumers having arrears for a period more than 3 years are only considered for settlement. Further, the Board vide order read as 3rd paper above extended the One Time Settlement Special Scheme to

- 1) Closed plantations and industrial units which have arrears for a period more than one year.
- 2) Other disconnected / dismantled consumers who have arrears for a period more than one year.

The Chief Engineer (Distribution Central), Ernakulam recommended the continuation of One Time Settlement scheme for a further period of three months. The Full Time Members of the Board examined the matter and the Board vide order read as 6th paper above extended the One Time Settlement Special Scheme till 31.01.2013.

In the Board meeting dated 29.01.2013, the Board has decided to ratify the action taken by the Full Time Members to extend the One Time Settlement Special scheme up to 31.01.2013 and further decided to extend the scheme to settle outstanding pending arrears of EHT, HT & LT consumers till 31.03.2013.

Orders are issued accordingly.
